After that I myself requested to the Director, but no positive solution came out except for the rounds of the office. When all the paper-work is complete which is submitted alongwith this Letter. After that I wrote letters to the Honourable Chief Secretary Government of Sindh and Secretary Education on 05th April 2024 & 15th May 2024, copies attached requesting them to solve the problem of ill lady Teacher.






